## Green Line Stations Upgraded to Improve Accessibility

### MINI-HIGH PLATFORM INSTALLED AT CLEVELAND CIRCLE

The MBTA opened a new 3-foot-high, 76-foot-long elevated platform on the outbound side of the Cleveland Circle Green Line station on May 2. The "mini-high" platform is the eighth such structure that the MBTA has built since February 2006 to improve access to Green Line trolleys for the elderly and people with disabilities.

"The Green Line is more accessible than ever to people with disabilities," said MBTA spokesman Joe Pesaturo.

The project to improve accessibility on the Green Line began in the spring of 2005, when the MBTA began evaluating the feasibility of building mini-high platforms at some of the busiest surface stations.

Mini-high platforms are now located at the following Green Line stations: Washington Street on the B Branch; BU Central (inbound) and Cleveland Circle (outbound) on the C Branch; Brookline Hills,

# Hybrid and Alternative-Fuel Vehicles Jump to the Head of the Line at Logan

## MASSPORT AND CITY OF BOSTON PROVIDE INCENTIVES FOR LOW-EMISSION VEHICLES

Finding a parking spot at Logan International Airport just got easier for drivers of hybrid and alternative-fuel vehicles as a result of programs sponsored by the Massachusetts Port Authority (Massport) and the City of Boston that encourage the use of low-emission vehicles.

In May Massport dedicated more than 100 parking spaces at Logan for the use of clean-fuel vehicles. Airport customers driving hybrid and alternative-fuel vehicles now have preferred

parking at the airport's Central Parking Garage (Level 6), Terminal B garage (Level 4), Terminal E surface lots, and Economy Lot. Eligible vehicles include those that use compressed natural gas (CNG), hybrid-electric, hydrogen fuel cell, and ethanol- 85 power sources.

Massport also worked closely with Boston mayor Thomas Menino and the city's Hackney Division to offer head-of-line privileges to clean-fuel Boston taxis at the airport's taxi queue. In the

past, taxis waited an average of 30 to 60 minutes before being dispatched to the airport terminals.

# Downeaster Ridership Up, Service Enhancements Underway

## EVENING RUN ADDED BETWEEN BOSTON AND PORTLAND

After five years in operation, Amtrak's Downeaster passenger rail service is proving to be an increasingly attractive means for traveling on the Boston-to-Portland corridor. Ridership on the line grew 32 percent during the last fiscal year, the largest percentage increase in the Amtrak system, said Patricia Quinn, Executive Director of the Northern New England Passenger Rail Authority (NNEPRA). NNEPRA is the coordinator of the partner organizations—including Amtrak and host railroads

Pan Am Railways and the MBTA—that make the running of the Downeaster possible.

As more travelers choose the train over driving on the high-



ways, the Downeaster service is being enhanced. The number of runs has been increased and collaboration with bus services is

helping to complete the overall service package.

The Downeaster currently makes four daily round-trips, which stop at Boston, Woburn, and Haverhill in Massachusetts; Exeter, Durham, and Dover in New Hampshire; and Wells, Saco, Old Orchard Beach, and Portland in Maine.

Approximately 74 percent of people who travel on the Downeaster are visitors to Boston, and about one-third of the travelers are commuters, according to Quinn.

To tap into a larger market, a fifth daily round-trip, departing from Portland at 8:00 PM, will

# 'Bikes on the T' Program Improves Cyclist Access to Transit

## BIKE RACKS TO BE INSTALLED ON ONE THIRD OF MBTA BUS FLEET

As National Bike Week got underway the week of May 14 and many Boston area commuters left their cars at home and peddled to work, the MBTA announced improvements to the transit system that are making it easier for bicyclists to access public transportation. Through its Bikes on the T program, the MBTA is equipping 35 percent of the MBTA bus fleet with bicycle racks as part of a phased effort with the ultimate goal

of fully outfitting the entire T bus fleet with racks. In addition, the MBTA is partnering with the Metropolitan Area Planning Council (MAPC) and Livable Streets Alliance to install additional bicycle racks at various subway and commuter rail stations.

Cyclists can currently take their bicycles on 125 buses that travel on 19 routes in the following communities: Allston, Arlington, Bedford, Belmont, Boston, Brighton, Burlington, Cambridge, Charlestown, Chelsea, Everett, Lexington, Malden, Medford, Revere, Somerville,

Waltham, Watertown, Winchester, and Woburn.

This summer, another 205 buses will be outfitted with racks. These buses will run on 41 routes and will add Beverly, Danvers, Lexington, Marblehead, Nahant, Newton, Peabody, Salem, and Swampscott to the communities served. All of the new buses that the MBTA will purchase in the future will come equipped with racks.

## Boston Region MPO Activities

### BOSTON REGION MPO ACTION ITEMS

The Boston Region MPO, at the recommendation of its Transportation Planning and Programming Committee, released an adjustment and an amendment to the federal fiscal year (FFY) 2007 Transportation Improvement Program (TIP) for public review. The adjustment allocates funding from the MPO's Suburban Mobility Program to several suburban transit service projects. The amendment adds two new transit projects, reallocates transit program funding, addresses carryover funding for two transit projects, programs federal discretionary and earmark funding, and adds a state discretionary grant. The Committee also released a draft of its revised Public Participation Program for a 45-day public review period. The Program has been revised to better comply with the Safe, Accountable, Flexible, and Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU).

### REGIONAL TRANSPORTATION ADVISORY COUNCIL UPDATE

Massachusetts, like other states, is facing an enormous transportation funding gap, said Paul Regan, Executive Director of the MBTA Advisory Board, MPO member, and member of the Transportation Finance Commission, at the Council's May meeting. In a discussion about the report *Transportation Finance in Massachusetts: An Unsustainable System*, Regan explained that, over the next

20 years, financial resources will fall somewhere between \$15 and \$19 billion short of the basic needs of transportation maintenance and state of good repair throughout the state's transportation network. The Commission has been presenting its findings to the public and asking for ideas on how to bridge the funding gap.

Joe Cosgrove, of the MBTA, summarized the proposed TIP transit amendment and adjustment that are under consideration by the MPO. (See details above under MPO Action Items.)

### ACCESS ADVISORY COMMITTEE TO THE MBTA (AACT) UPDATE

At its May 23 meeting, AACT members elected Ben Haynes as Chair and Philip Beaulieu as Vice Chair for the 2007 to 2009 term. Don Summerfield, Frank Taverna, and James Oliver were elected to the Executive Board.

The Office for Transportation Access (OTA) announced that monitors have been riding MBTA buses to determine compliance with ADA requirements for calling out

stops. In April 107 bus trips were monitored, and 82 percent were found to be in compliance.

OTA staff are continuing to visit senior centers to register MBTA customers for the Senior/TAP/ Blind Access CharlieCards. be added. The evening run will better serve tourists from Boston and points south who spend the day in Portland and those from Portland and points north who wish to attend sporting or other events in Boston in the evenings. Bus service is currently being offered during this time slot.

NNEPRA has been working with two bus companies, Concord Trailways and C & J Trailways, to coordinate bus schedules with train schedules and to offer passengers a FlexPass, which can be used on either the train or bus.

As part of a \$6 million capacity improvement program, an effort is also underway to reduce the train's travel time between Boston and Portland to make the train more competitive with automobile travel.

There is interest in Maine for extending the service to Brunswick, Maine. In March a \$40 million bond proposal for infrastructure improvements on the line was presented in the Maine state legislature, but it was not included in the final borrowing package signed by Governor Baldacci in April.

on the D Branch; and Museum (outbound) on the E Branch. A mini-high platform will be built at the St. Mary's Street stop in late 2007.

The MBTA's recent acquisition of 85 low-floor cars from the

Italian manufacturer Breda is also improving to accessibility on the B, C, and E branches. Each train set on those branches has at least one new Breda car, which allows passengers to board from raised platforms using an on-board ramp, without stepping up or down.

Mayor Menino announced a new \$25,000 grant to increase participation in the program and to offset the costs of new hybrid and alternative-fuel taxis.
